# Call Before You Dig...




Even the most basic digging project requires a call to JULIE. From planting a tree to installing a fence, you should know what is below before you dig. Utility lines could be buried just beneath your dig site. Hitting a utility line can cause serious harm, disrupt service and result in costly repairs and fines.

Red - Electric
Yellow - Gas, oil or petroleum
Orange - Communications
Blue - Potable water
Purple - Reclaimed water, irrigation
Green - Sewer
White - Proposed excavation
Pink - Temporary survey

It is also important to premark your project with white paint or white flags before notifying JULIE.
